Once snapshot isolation is enabled, updated row versions for each transaction are maintained in tempdb. A unique transaction sequence number identifies each transaction, and these unique numbers are recorded for each row version. The

transaction works with the most recent row versions having a sequence number before the sequence number of the transaction.

Newer row versions created after the transaction has begun are ignored by the transaction.

You administer a Microsoft SQL Server 2016 database that includes a table named dbo.Log. This table contains millions of records about user activity in an application.
