Choice c is incorrect because it is also awkward and does not have the helping verb will to indicate the future tense of the verb. Choice d is incorrect because it creates a run-on sentence. Choice e is grammatically correct but bulky and awkward because it uses is going to bring instead of will bring and because, like choice a, it places of after draft.
